



EVENT INFORMATION

1. CLUB & INDIVIDUAL REGISTRATION

- 1.1. The athlete can be registered via a club or individually. An athlete may register individually, but must provide the details of the club they represent.
- 1.2. The athletes must bring the flag of the club they are registering.

2. EQUIPMENT, MATERIALS & UNIFORMITY

The equipment and materials needed to participate the events are according the CMAS rules.

3. PARTICIPATION

- 3.1. Do not exist a limit number for athletes' registration.
- 3.2. The event is a Senior, Male & Female from 18 years old (older than 01/01/2007)
- 3.3. The athletic age of an athlete is obtained by subtracting his year of birth from the current year. The athlete will compete from January 1 until December 31 of the year in this category
- 3.4. No athlete is admitted taking part in a competition of an age category lower than his/her own age category.
- 3.5. The athletes need to submit proof of personal accidents insurance valid in Portugal for the dates of the event in the moment of registration in the event.
- 3.6. The registration needs to be made by the clubs or athletes using the official form for registration.
- 3.7. The registration form needs to send to secretaria@fpas.pt until the deadline of **5th of October of 2025.**
- 3.8. The registration is considered complete with the payment.

9. DOPING CONTROL


The anti-doping procedures will be according to the CMAS rules and regulations.
